

Artist Call: Carved cedar ceremonial doors at Oakridge Community Centre

Land acknowledgement

Eligibility: Open to xʷməθkʷəy̓əm (Musqueam) Indian Band artists or artist teams

Guiding Frameworks

This artist call is guided by the City of Vancouver's commitments outlined in [Culture|Shift 2020-2029](#) and the [UNDRIP Action Plan 2024-2028](#). The strategic directions outlined in these frameworks inform how we design, assess, and support these art opportunities, with a focus on advancing equity, Reconciliation, accessibility, and meaningful inclusion.

The City's Public Art Program and the Vancouver Public Library are participants of the UNDRIP Action Group 9 'Public Realm,' with commitments to increasing the presence of the local Nations in library spaces through art calls, and cultural visibility public art projects across Vancouver.

Eligibility

This call is open for xʷməθkʷəy̓əm (Musqueam) Indian Band artists or artist teams.

For the purposes of this call, the definition of an artist is a regular practitioner who:

- has completed basic academic training in art or an apprenticeship with an accomplished practitioner in the field, or

- maintains an artistic practice and has publicly shared an independent body of their work for at least two years, or
- is recognized as an artist by arts and culture peers within their community

Submitted Applications will be checked for eligibility and completeness by City Staff in collaboration with Musqueam Indian Band staff, with qualifying applications moving forward to the selection panel for adjudication.

Background

Oakridge Park is a 28-acre development site at 41st and Cambie. Located in the heart of Vancouver's Cambie Corridor, the Oakridge site sits within an area of longstanding cultural and historical significance to the xʷməθkʷəy̓əm (Musqueam) people. The project replaces a 1950s mall and its surface parking lot with a new neighbourhood including 10 towers, 3000 residences, 700,000 square feet of office space, 650,000 square feet of retail space, and nine acres of new park space, much of it wrapping over the mall's roof. The development will also deliver the new Oakridge Community Centre to be operated by the City, with a branch library, performance venue, childcare facility, and artist studios.

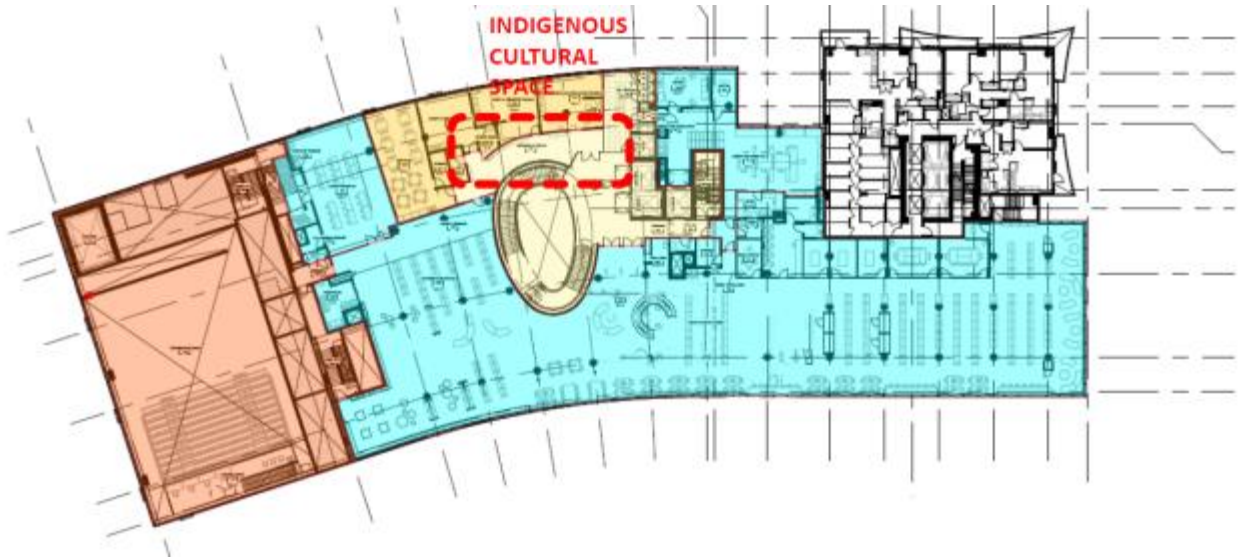
The Opportunity

The Oakridge Community Centre offers three key sites to commission three significant xʷməθkʷəy̓əm (Musqueam) artworks including the central atrium, the Indigenous Contemplation Space, and the library (see images below). These cultural visibility opportunities are being developed in collaboration between the City of Vancouver Public Art Program, and Vancouver Public Library. Artists or artist teams can apply for more than one opportunity.

OPPORTUNITY #2: CARVED CEDAR CEREMONIAL DOORS

Artist Fee: \$15,000

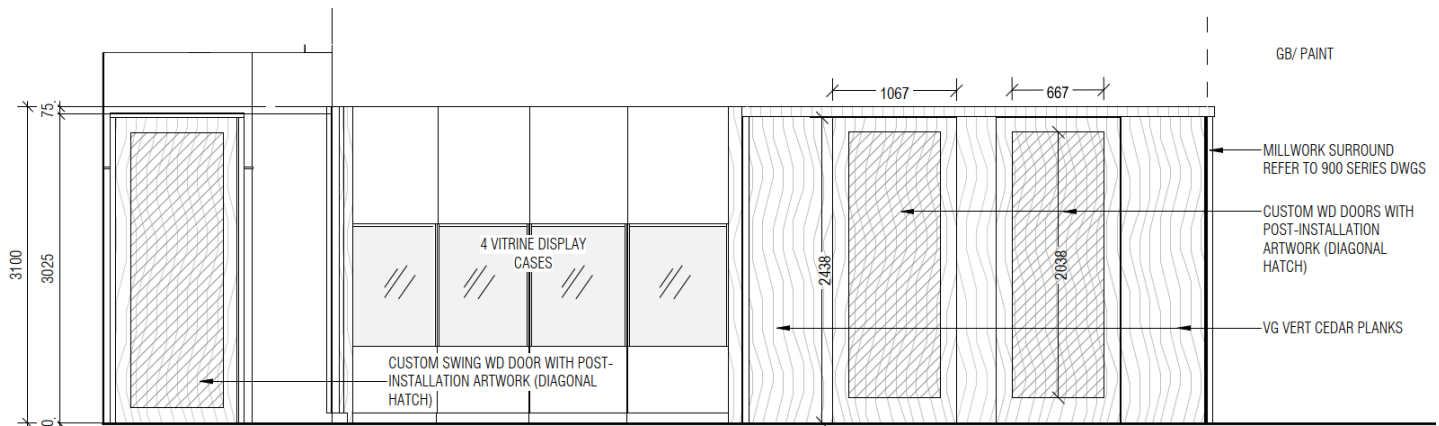
This is a design-only opportunity for an artist or artist team to create a traditional Coast Salish design that will be integrated into three red cedar veneer panels via CNC technology. These panels will be installed onto the entrance doors of the Indigenous cultural studio space for artists and cultural practitioners in residence.



Located on Level 2 of the Oakridge Civic Centre

The selected artist or artist team will be required to meet the design specifications below:

- Dimensions of each panel: 3 feet 6 inches wide x 8 feet high

Submission Requirements and Guidelines – Opportunity 2

Applicants may only submit one Expression of Interest, whether applying individually or as part of a team. The following must be submitted to qualify for consideration:

1. **Contact information:** full name, pronouns, email and phone number
2. **Identity Statement:** a brief statement that identifies your Nation affiliation and any intersectional identities such as gender, disability, etc. (Applicants are only required to share to the extent of their comfort levels).
3. **Artist Bio:** (max. 2 paragraphs per person if applying individually or as a team) a short synopsis of your art practice and any former training
4. **Sample Artwork:** 4–6 images of your artwork, with brief descriptions. Previous built-form public art experience is asset, but not mandatory. Accepted formats: JPG, PNG, PDF
5. **Statement of Intent:** A short description (300-500 words) of a preliminary idea, story, design concept, and/or artistic approach to the artwork.

Application and Selection Process – Opportunity 2

Applicants will go through an Expression of Interest (EOI) process, wherein the adjudication panel will select an artist based on their portfolio of past works to enter the stages of creating a design. Support will be provided by technical advisors from the project team. The stages of creating the artwork and their deliverables are:

- Concept Proposal: Narrative document outlining approach to the commission, showing examples or rough sketches of what the final work will look like.

- Detailed Draft Design: A draft digital design showing artwork to 75% for project team to review.
- Final Design: Delivery of digital files and technical drawings to the project team.

The overall project timelines are determined by the timeline of construction, estimated to be completed in December 2026. It is anticipated that the final design for the artwork will be completed by December 2026, with fabrication and installation early 2027.

Applications will be reviewed by arts and culture professionals and xʷməθkʷəy̓əm representatives who bring deep knowledge and experience in the arts, language, curatorial practice, and cultural protocols.

Criteria for Selection of Artists

The adjudication panel will score applications based on:

- Artistic quality, creativity, and originality evident in past work
- Successful artistic production and exhibition to diverse audiences
- Demonstrated ability and capacity to execute digital design to required technical standards
- Shows meaningful connection to the project and its community impact
