THAT the Urban Aboriginal Peoples' Advisory Committee agrees to have Steven Eastman, Lillian Howard, Penelope Irons, and Genoa Point write a letter on behalf of the Committee, stating their unanimous support with the Musqueam Nation with regards to protecting their sacred burial site at Marpole Midden from condo development.

FURTHER THAT the Committee respectfully makes themselves available for any submission the Musqueam Nation may wish to make to the Committee.

AND FURTHER THAT Genoa Point be the liaison for the Committee in all communications with the Musqueam Nation.
