RECOMMENDATION

The Chief Procurement Officer recommends that, pursuant to the City's Procurement Policy ADMIN-008, and subject to final negotiations as to the forms of written agreement, the Bid Committee approve the following three (3) contracts:

Solicitation Number:	PS20220117-TS-RFEOI - Data and Analytics Cloud Platform	
Description of the Goods or Services:	City-wide cloud-based data management, reporting and analytics services.	
Recommended Vendors:	(1) MNP LLP (2) Slalom Consulting ULC (3) Informatica LLC	
Contracts Term and Estimated Contracts Value:	The recommended duration for the two contracts with MNP LLP and Slalom Consulting ULC is 3 years each, with options to extend for two additional one-year periods. The estimated combined total cost over the initial terms is \$1,250,000 plus applicable taxes. The recommended duration for the contract with Informatica LLC is 2 years. The estimated total cost over the term is \$210,684.18 plus applicable taxes. Total Cost of all three contracts: \$1,460,684.18 plus applicable taxes.

- d) Bid Committee approval authority exists, as outlined in the City's Procurement Policy ADMIN-008 due to the value being in excess of \$1 million;
- e) The Senior Category Manager, Chief Procurement Officer and Chief Technology Officer Services to be authorized to execute and deliver all legal documents on behalf of the City; and,
- f) The Bid Committee approval is pre-contract award, the final contract information may vary subject to final negotiations and award.

DECISION

The Bid Committee approved the entry into three (3) contracts in relation to PS20220117-TS-RFEOI - Data and Analytics Cloud Platform with MNP LLP, Slalom Consulting ULC, and Informatica LLC (subject to final negotiations), under the authority of the City's Procurement Policy ADMIN-008.
