### RECOMMENDATION

Recommendation to enter into memorandums of understanding along with subsequent construction contracts, as and when needed, with the following five (5) contractors, King Hoe Excavating Ltd., JJM Construction Ltd., BD Hall Constructors Corp., B&B Heavy Civil Construction Ltd. and Jacob Bros. Construction Inc. in relation to Request for Applications PS20230378-ENG-RFA Contractor Pre-Qualification for Closure and Other Landfill Works.

The Chief Procurement Officer recommends that the Bid Committee approve the entry into the following contracts, under the authority of the City's Procurement Policy ADMIN-008 provided that such contracts shall not be entered into until it is also approved by Council, as required by such policy (subject to final negotiations).

Description of the Goods or Service:	Program for prequalified contractors to be invited to two (2) or more Invitation to Tenders for landfill closure work and ancillary services for the Vancouver Landfill.
Recommended Vendors:	King Hoe Excavating Ltd., JJM Construction Ltd., BD Hall Constructors Corp., B&B Heavy Civil Construction Ltd. and Jacob Bros. Construction Inc.
Contract Term and Estimated Contract Value:	The recommended term of the prequalification period is three (3) years.  The estimated program value is \$45,000,000.00, plus applicable taxes, over the three (3) year term of the program.

- c) Financial Planning & Analysis and the applicable business unit have reviewed and concur on the budget and recommendation;
- d) Bid Committee approval authority exists, as outlined in the City's Procurement Policy ADMIN-008 and Council approval is required under the City's Procurement Policy ADMIN-008, due to the value being in excess of \$2 million;
- e) The Category Manager, Director of Legal Services, under the City's Procurement Policy, Chief Procurement Officer and General Manager of the Engineering Services Department to be authorized to execute and deliver all legal documents on behalf of the City; and,
- f) The Bid Committee approval is pre-contract award, the final contract information may vary subject to final negotiations and award.
