## **COMMENTS**

The recommended contract meets the following requirements:

- a) The City advertised the procurement in accordance with the City's Procurement Policy (ADMIN-008);
- b) The proposed vendors offer the best value and scored the highest, which City staff calculated in accordance with the criteria, factors, and methods stated in the City's solicitation documents;

- The City's Financial Planning & Analysis department and the client business unit reviewed and concurred on the procurement budget and the selection of the proposed vendors;
- d) Pursuant to the City's Procurement Policy (ADMIN-008), the Bid Committee and Council have authority to approve the contract because the total price is greater than \$3,000,000;
- e) If Bid Committee approves this report and Council subsequently approves a related Council Report, the City's Category Manager, Director of Legal Services, Chief Procurement Officer, and General Manager of the Engineering Services Department will have the authority to negotiate, execute, and deliver all legal documents for this procurement on behalf of the City; and
- f) As the Bid Committee approval is a pre-contractual award, the terms and conditions of the final agreements may vary as a result of the negotiation with the proposed vendors.

#### **DECISION**

Pursuant to the City's Procurement Policy (ADMIN-008), the Bid Committee approved the entry into memorandums of understanding and subsequent construction contracts in relation to Request for Applications PS20240711-ENG-RFA Construction Services for Sewer and Other Utility Work - Contractor Prequalification with B&B Heavy Civil Construction Ltd., BD Hall Constructors Corp., Jacob Bros. Construction Inc., Oscar Renda Contracting of Canada Inc., NorLand Limited, Clearway Construction Inc., and Complete Utility Contractors. The memorandums of understanding and subsequent construction contracts will not be executed until the program is also approved by Council.
