Vancouver City Council will hold a Public Hearing to consider the following matters:

1. Miscellaneous Amendments Concerning Various CD-1
By-laws and Schedule E of the Zoning and Development By-law
To make miscellaneous amendments to by-laws for the following:
CD-1 (369) for 901-967 and 940-990 Seymour Street, CD-1 (691) for
500-650 West 57th Avenue, CD-1 (876) for 1961-1995 East Broadway
and 2465 Semlin Drive, CD-1 (305) 1899 West 1st Avenue, and
Schedule E of the Zoning and Development By-law to improve clarity,
update references, correct inadvertent errors or omissions, and/or
improve the administration of the by-laws.

2. Rezoning: 626 West 32nd Avenue

To rezone 626 West 32nd Avenue from R1-1 (Residential Inclusive) District to RM-8A (Multiple Dwelling) District, to permit a townhouse development with a maximum floor space ratio (FSR) of 1.20.

3. Rezoning: 2520-2544 West 16th Avenue and 3223 Larch Street
To rezone 2520-2544 West 16th Avenue and 3223 Larch Street from
R1-1 (Residential Inclusive) District to RR-2B (Residential Rental)
District, to permit the development of a five-storey residential rental
building with a partial storey for rooftop amenity space (optional).
A floor space ratio (FSR) of 2.40 is proposed.

4. Rezoning: 5889-5925 Dunbar Street

To rezone 5889-5925 Dunbar Street from R1-1 (Residential Inclusive) District to RR-2B (Residential Rental) District, to permit the development of a five-storey residential rental building with a partial storey for rooftop amenity space (optional). A floor space ratio (FSR) of 2.20 is proposed.

Vancouver City Council will hold a Public Hearing to consider the following matters:

A. CD-1 Rezoning: 1434-1456 West 8th Avenue

To rezone 1434-1456 West 8th Avenue from C-3A (Commercial) District to CD-1 (Comprehensive Development) District, to permit the development of a 25-storey mixed-use building containing 154 rental units, of which 20% of the residential floor space will be for below-market rental units, with commercial space on the ground floor and second level. A floor space ratio (FSR) of 8.0 and a height of 77.8 m (255 ft.), with additional height for rooftop amenity and mechanical appurtenance spaces, are proposed.

B. CD-1 Rezoning: 1190 West 10th Avenue

To rezone 1190 West 10th Avenue from RM-3 (Multiple Dwelling) District to CD-1 (Comprehensive Development) District, to permit the development of a 21-storey mixed-use building, with 172 rental units with 20% of the residential floor area for below-market rental units and commercial space on the ground floor. A floor space ratio (FSR) of 6.8 and a height of 66.6 m (218 ft.), with additional height for rooftop amenity space, are proposed.



C. CD-1 Rezoning: 1245-1265 West 10th Avenue

To rezone 1245-1265 West 10th Avenue from RM-3 (Residential) District to CD-1 (Comprehensive Development) District, to permit the development of a 20-storey residential building with 164 rental units. A floor space ratio (FSR) of 6.50 and a height of 62.1 m (204 ft.), with additional height for rooftop amenity space, are proposed.
