1. Apply online at cra.gc.ca/myaccount **or**
2. Call 1-800-267-6999
Press 1, then 1, then 2
Provide:
 - a.) Social Insurance Number
 - b.) Date of Birth
 - c.) Income reported on **line 150** of your **2017** tax return (T1 General)

Canada Revenue Agency (CRA) will send your “Proof of Income Statement” to your CRA online account or mail it to your home.
