

TEMPORARY MODULAR HOUSING

THE LOTS AT 1115, 1131 AND 1141 FRANKLIN STREET AND 501 POWELL STREET ARE BEING CONSIDERED AS SITES FOR TEMPORARY MODULAR HOUSING

You are invited to a community information session for Temporary Modular Housing buildings that are being considered for the lots at **1115, 1131 and 1141 Franklin Street and 501 Powell Street**.

For these lots it is expected the buildings on each site will be three storeys and between 38 - 52 homes. If approved, the buildings will be in place for up to five years, with the possibility to extend another five years.

The City, VAHA and BC Housing will host a Community Information Session about the Temporary Modular Housing proposed for these sites.

A Community Liaison is available to respond to Temporary Modular Housing inquiries for these sites.

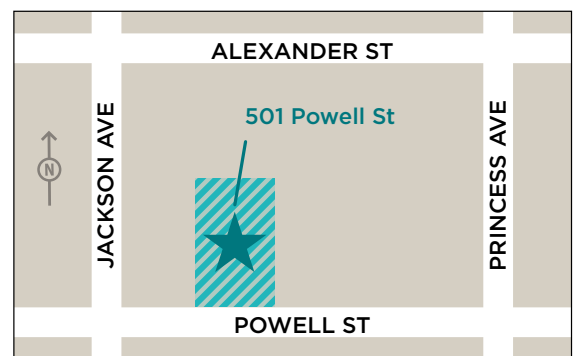
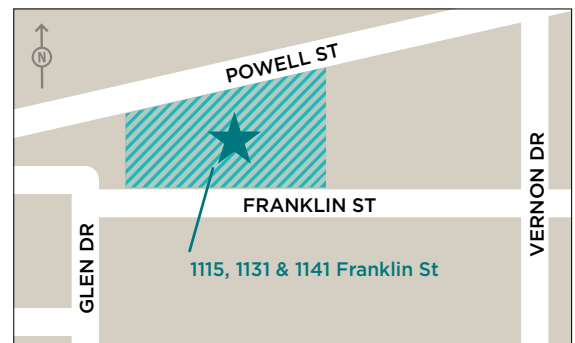
Vancouver is in the middle of a housing crisis and the City's lower income and homeless residents are the hardest hit. In an effort to address the effects of the crisis on this community, the City of Vancouver is working alongside the provincial government and BC Housing, to build 600 units of Temporary Modular Housing on vacant sites across the city.

These sites have been selected because they are waiting to be redeveloped; people can be moved into homes quickly; have space to accommodate the buildings; can easily connect to water, sewer, hydro; are close to transit and/or services; and will allow the homeless people living in the area to remain in their community.

社区联络员会在场回答关于这些地块所建临时组合房屋的查询。

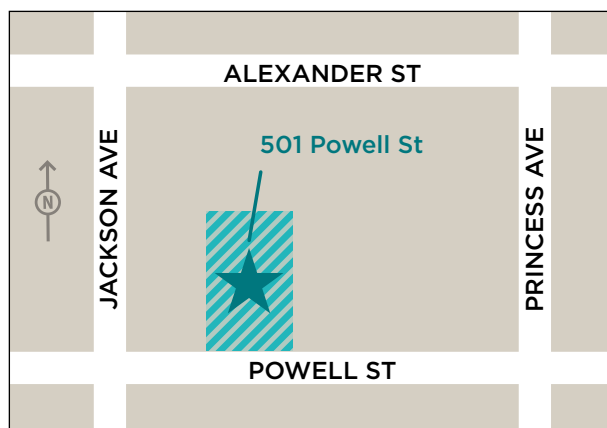
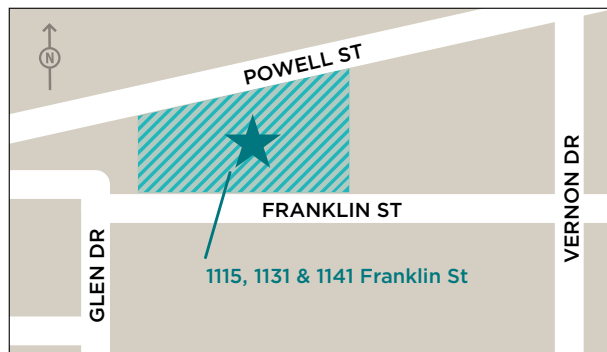
