TEMPORARY MODULAR HOUSING

THE SITE AT 898 MAIN STREET IS BEING CONSIDERED FOR TEMPORARY MODULAR HOUSING.

The City of Vancouver, in partnership with the Vancouver Affordable Housing Agency (VAHA) and BC Housing, is building temporary modular housing on various sites across the city to create much-needed housing for people experiencing homelessness.

The site is expected to have one three-storey building containing approximately 50 single-occupancy homes. Priority for homes will be given to Indigenous residents experiencing homelessness. At least 10% of the units would be wheelchair accessible. The building would be in place for three to five years, with the possibility to extend another five years and would be managed 24 hours a day, 7 days a week, by an experienced non-profit housing operator.

The proposed temporary modular housing project will not delay or impede the delivery of the Northeast False Creek Plan, including the removal of the viaducts, the development of permanent social housing, and the establishment of a cultural centre for the Black Community on the 898 Main Street block (Hogan's Alley block) as a place that will be welcoming and inclusive to all.

HOW YOU CAN LEARN MORE

- The project partners will hold a Community Information Session to answer questions, and listen to the community's feedback on the proposed project.
- Staff will conduct walkabouts to connect with residents and businesses.
- Input will be considered by the Director of Planning when deciding on a development permit for the project.
