DRIVER TRAINING INSTRUCTION:

VEHICLES FOR HIRE BY-LAW: SECTION 16(5)

- 16(5) A person may keep and use premises for the business of motor vehicle driver instruction in a residential dwelling unit but only if that person:
- (a) and those premises comply with the Zoning and Development By-law including, without limitation, section 11.6 [outlined below];
  - (b) licenses only one driver instruction vehicle under this By-law for use in that business, and uses only that motor vehicle in the business;
  - (c) does not permit any students or employees of the business to attend at the premises; and
  - (d) is the only person carrying on the business at the premises.

ZONING AND DEVELOPMENT BY-LAW: SECTION 11.6 .

- 11.6.1 No person other than one resident member of the family occupying the dwelling shall be engaged in the homecraft(\*) on the premises.
- 11.6.2 Where located in an "R" District, there shall be nothing to indicate from the exterior of the dwelling unit or building that it is being used for any purpose other than its principal or approved use.
- 11.6.3 No products or material shall be sold from or within the dwelling unit, building or accessory
- 11.6.4 No products or material shall be stored outside of the dwelling unit, building or accessory building
- 11.6.5 No offensive noise, colour, vibration, smoke, heat or other objectionable effect shall be produced.

\*Homecraft means a craft or occupation conducted as an accessory use subordinate to the principal residential use of a dwelling unit, and must only be conducted within the principal building on the site.

VEHICLE FOR HIRE CHARTER

STREET AND TRAFFIC BY-LAW: SECTION 20.2

- Except for
- (a) vehicle which is designed primarily for the conveyance of passengers and has a seating capacity not exceeding 9 people, an overall height not exceeding 2.2 m and an overall length not exceeding 6.4 m, and
  - (b) truck with a licensed gross vehicle weight not exceeding 5 500 kg and an overall length not exceeding 6.4 m no person shall park a vehicle on a street abutting property used for a public park, school, church or residential purposes for more than 3 hours between the hours of 6:00 a.m. and 10:00 p.m., unless the vehicle is needed for a service call or the property is a construction site.

ZONING AND DEVELOPMENT BY-LAW: SECTION 10.17

- 10.17.1 No boat, boat trailer, truck, bus or similar vehicle shall be placed or parked on any site in an R. District except for the following:
- a) one truck with a registered gross vehicle weight not exceeding 4550 k

ZONING AND DEVELOPMENT BY-LAW: SECTION 11.6 .

- 11.6.1 No person other than one resident member of the family occupying the dwelling shall be engaged in the homecraft(\*) on the premises.
- 11.6.2 Where located in an "R" District, there shall be nothing to indicate from the exterior of the dwelling unit or building that it is being used for any purpose other than its principal or approved use.
- 11.6.3 No products or material shall be sold from or within the dwelling unit, building or accessory
- 11.6.4 No products or material shall be stored outside of the dwelling unit, building or accessory building
- 11.6.5 No offensive noise, colour, vibration, smoke, heat or other objectionable effect shall be produced

\*Homecraft means a craft or occupation conducted as an accessory use subordinate to the principal residential use of a dwelling unit, and must only be conducted within the principal building on the site.
