Self-initiated application submission requirements

- VHR Application Form (begins on page 2)
 - a) Current and historic photographs (Provide the source for all photos) Submit photos showing all sides of the place. Include any architectural features (for example, windows, cornices, porches, roof details, landscape features, and more). Include notable interior finishes and features (for example, fireplaces, stairs, walls, floors, ceiling treatments, built-in fixtures, and more).
 - b) Provide street view photos of the place.
- Research documentation (applicable sections of pages 3-8)

Supporting material:

- a) Submit copies or summaries of historical information or documents relating to the historic context or heritage value of the place. These can include fire insurance maps, residential directories, blueprints, newspaper articles, history books, or other historical materials.
- b) Provide evidence of lived experience associated with the place: This can be in the form of audio recordings, transcribed interviews, and more. Include a brief explanation of how these materials support the heritage value of the place.
- c) If the applicant has an existing Statement of Significance (SOS) for the place complete with current and archival photos and relevant research, it can be submitted instead of the itemized materials listed above.
