WEST END COMMUNITY PLAN IMPLEMENTATION

Development Applications

A development application for a mixed-use building at **1661 Davie Street** is proposed by Henriquez Partners Architects. Rezoning Applications

A rezoning application for a 56-storey residential building at **969 Burrard Street** and **1019-1045 Nelson Street** is proposed by Bing Thom Architects.

The proposal includes restoration of First Baptist Church including a 37-space child daycare, a gymnasium, a counselling centre and offices, a new eight-storey building containing 66 social housing units owned by the church, and a new 56-storey tower containing 294 market strata residential units.
