- You have been a resident of B.C. for at least 6 months immediately before the day of registration;
- You have been a registered owner of the real property described above in the City of Vancouver for at least 30 days immediately before the day of registration;
- The only persons who are registered owners of the real property, either as joint tenants or tenants in common, are individuals who are not holding the property in trust for a corporation or another trust;
- You have received the written consent of the majority of registered owners for the real property, authorizing you to be registered as the non-resident property elector for this property (if applicable);
- You have not registered as a non-resident property elector in relation to any other parcel of real property in the City of Vancouver; and
- You are not disqualified by any enactment from voting in an election or are otherwise disqualified by law.
