Stanley Park Pitch & Putt: Nestled in the heart of historic Stanley Park, this course boasts well-designed fairways, mature trees, and pristine greens. Its central location in Vancouver's downtown area makes it an excellent option for corporate gatherings looking to blend leisure with the city's vibrant atmosphere.



Rupert Park Pitch & Putt: This course offers elevated greens and strategically placed water hazards, providing an ideal setting to challenge your skills and refine your short game. Enjoy the stunning backdrop of the North Shore Mountains. Conveniently located with easy access from Hwy #1 and First Ave, it's a great choice for a day on the green.



Queen Elizabeth Park Pitch & Putt: Ideal for beginners and those seeking a leisurely round, this course is set amongst the exquisite gardens and blooming trees of Queen Elizabeth Park. Easily accessible by the Canada Line, it offers ample space for additional event setups and sponsorship displays, enhancing your tournament experience.

STEP #3: AGREE TO GOLF TOURNAMENT TERMS AND CONDITIONS

Payment Terms and Deposits

incomplete foursomes (three players or less) will be charged as a full foursome. Payment will be done on the course before the group goes out to play.

Cancellation

Notice of cancellation of tournaments held on Pitch and Putt courses must be received in writing or via email 7 days prior to the event date.

Guaranteed Numbers

In order to properly prepare for your arrival and ensure adequate staffing, materials and tee times a final guarantee accompanied by your final payment is due 14 days prior to your event date.

Food and Beverage

Food purchase is mandatory at the Pitch & Putt tournament bookings. All food and beverage consumed onsite by the tournament participants shall be purchased at the course. If you would like a Food & Beverage Package such as a Golf & Snack—Sandwich, pop and chocolate bar or bag of chips—please ask your coordinator at least one week in advance. Final numbers must be provided one week in advance, and menu selections are subject to availability.

Liability

The function convener and/or the organization whom they represent shall be held liable for all damages not associated with the normal wear and tear that may arise as a result of the actions of the function guests. Replacement values shall be used as the amount payable for damages, including lost revenue resulting from such damages. The function convener and/or the organization whom they represent assumes responsibility for the repair and/or replacement rental equipment in the event that these items are damaged, lost or stolen. A damage deposit is required.

The Vancouver Board of Parks and Recreation Golf Courses shall not be responsible for the security of any personal property or equipment brought or delivered to the site. Authorized agents of the venue must be contacted prior to setup of displays or signage to ensure that no damage arises as a result of the setup.

The Vancouver Board of Parks and Recreation Golf Courses are a shared and publicly funded community asset and the use of the facility should reflect this. Users of the facility shall comply with all applicable City By-laws, Federal and Provincial legislation, including the British Columbia Human Rights Code which prohibits discriminatory conduct including conduct that exposes any person(s) or group(s) to hatred or contempt.

Health and Liquor Board Regulations

In accordance with the Health and Liquor Board Regulations of British Columbia, all food and beverages shall be purchased from the Golf Course. Staff members reserve the right to refuse service to any individual(s) who, in the opinion of the staff, appear intoxicated or are exhibiting misconduct due to alcohol consumption.

Inclement Weather

Tournaments will be played as scheduled except when the Superintendent of the course determines the golf course to be unplayable.

General Golf Course Conduct Rules

The group representative is responsible for the conduct of all participants, and shall inform all players of the rules, ensuring they are followed at all times.

All signs must be approved and received a minimum of two hours prior to the start of the tournament.

The Course Players Assistant's instructions shall be strictly adhered to. The PA's have the authority to ask players to pick up their ball and advance to the next hole or remove players who do not comply with Pace of Play policies by keeping up with the group in front of them.

Each player must play with their own set of clubs.

Golf bags and pull carts must be kept clear of all tees and greens.

Players must play in foursomes except when instructed by Golf Shop.

Smoking is prohibited as per City of Vancouver Bylaws.

Outside alcoholic beverages are not permitted on the course.

No spectators are permitted on the course or with the groups unless authorized in advance by Golf Management.

Maximum four players per group.

VANCOUVER PARK BOARD BEHAVIORAL EXPECTATIONS

We expect that everyone in our spaces will:

- Take responsibility for their own behavior
- Will talk in a normal tone and avoid swearing
- Keep their cool and treat others with respect
- Not damage or take equipment or property that does not belong to them.
- Ensure they are not intoxicated

These behaviours will result in the user groups or individual(s) responsible having appropriate measures implemented to prevent these behaviours being repeated. Measures may include verbal warnings, development of behavioural expectation agreement, access restrictions, and suspension or termination of use of park and recreation facilities, services and access to properties.

Without limiting our policy statement, the following behaviour is unacceptable and staff will be required to report any occurrence involving them:

- Anti-social or negative behaviour resulting from intoxication or the use of drugs or alcohol,
- The consumption of alcohol or drugs in our washroom facilities,
- Smoking or vaping within our spaces,
- Bringing weapons into our spaces, Violent or aggressive behaviour,
- Theft or vandalism of recreation or patron property,
- Making threats, attempting to intimidate, goading and inciting others to violence,
- Any action that promotes discrimination, racism or hatred,
- The use or display of abusive or offensive materials, words, or images,
- Any action that damages, defaces, fouls or pollutes any Vancouver Park Board property,
- Any activity or conduct that would be detrimental to the environment at the site, breaches posted rules and may negatively affect those in the immediate surrounding area.
