Attached please find the requested data.

In response to your request for Calls for Service, we extracted information from the Computer Aided Dispatch (CAD) database. These totals can be found in worksheets 7, 8 and 9 of the attached data set. This compiled data provides you with the number of calls for service made to police. Please be advised that not all calls for service to police result in the creation of a police report.

With respect to the remainder of your request, we conducted a search for all reports generated using as a primary designation the Uniform Crime Reporting (UCR) codes you provided for Assault, Robbery and apprehensions made under section 28 of the *Mental Health Act*. This data is compiled at worksheets 1-6 and 9 of the attached spreadsheet. Please note the UCR code "Assault" does not include sexual assault or incidents of domestic violence.
