CIRCUMSTANCES OF INCIDENT

On 2016-05-20 at approximately 1147 hours 22(3)(b), 22(1) ), 22(3)(b), 22(1) , phoned police to report he had approached the Wind Mobile Store located at 336 Robson St 22(3)(b), 22(1) , but noticed the store was closed and lights were off, which appeared strange to him considering the time of day. Upon further inspection, 22(3)(b), 22(1) observed a leg sticking out from behind the counter. 22(3)(b), 22(1) tried to open the door but it was locked. 22(3)(b), 22(1) then banged loudly on the door 22(3)(b), 22(1) . No other movement was seen.

POLICE ACTIONS

At approximately 1153 hours 22(3)(b), 22(1) , in company of 22(3)(b), 22(1) attended the scene and immediately set up front and rear containment of the building to make observations. 22(3)(b), 22(1) set up at the front of the store and 22(3)(b), 22(1) set up in the rear lane.

22(3)(b), 22(1) observed the store appeared to be closed as the lights were off.

22(3)(b), 22(1) spoke with 22(3)(b), 22(1) who stated 22(3)(b), 22(1)

The Vancouver Police Emergency Response Team (ERT), Kanine Units, negotiators and additional patrol units were called to the scene to assist with containment and entry plans. Car 10 was advised of the file. Containment was set up to cover the front and back, as well as the common hallway inside the building which provided the rear exit to the store.
